

**MINUTES OF THE MEETING OF BARROW PARISH COUNCIL HELD ON TUESDAY 19TH
MARCH 2019 AT 6.30PM AT WILLEY VILLAGE HALL.**

1. PUBLIC PARTICIPATION:

Six members of the public were present. Two residents attended and spoke regarding the allotment site including reading out their letter of appeal. No other comments were made by the public.

2. ACCEPTANCE OF APOLOGIES: There were no apologies.

3. TO RECORD THOSE MEMBERS PRESENT: All councillors were present along with Shropshire Councillor Turner. They all signed the attendance book.

4. DECLARATIONS OF INTEREST AND DISPENSATIONS: None.

5. MINUTES: To confirm the Minutes of the meeting held on 19th February 2019 and 15th January 2019. The minutes of both meetings were signed and approved.

6. REPORT BY SHROPSHIRE COUNCIL MEMBER:

Shropshire Councillor Turner reported he obtained an update on the planning application for the Eco pod site on Spout Lane. He is pressing for a swift decision. Highways dept are introducing 29 new posts which should make a substantial difference to the highway condition. He has met with senior officers regarding the HGV scheme and lack of completion. There is still a fair bit to do on the snagging list. The Broseley end of the scheme has not yet started. The Place Plan meeting had representation from the Parish. The council tax band D rate for Shropshire Council will be £1388. On top will be the police, fire service and parish amounts. His next advice surgery will be at Much Wenlock Museum on 6th April 2019.

7. LOCAL JOINT COMMITTEE: No meeting no report.

8. POLICE MATTERS:

PCSO Goddard was in attendance. He reported there is no police constable allocated to the Much Wenlock and Broseley Safer Neighbourhood team at present. There are times when an officer with a warrant card is required. The current team will be attending as many parish council meetings as work load allows. The inspector and Sargent that head up the SNTeam are responsible for several other SNTeams. There are 115 new police officers due to start work soon. That is 115 more than the current number. These officers should be steered towards the smaller rural stations. Bridgnorth Station does have an active reactive team. It was agreed to write to the Police and Crime Commissioner and Chief superintendent requesting a new SNT police constable is installed for the Much Wenlock area. **Clerk to action.**

9. HGV SCHEME. A. update. The scheme is not complete Councillor Churchill and Knott are keeping an eye on the snagging work. It is noted that the Benthall Hall signs send people in different directions. The signs are at St Mary's road. **Clerk to report.**
