#### Report

### 10. St Giles Churchyard.

Clerk has tried to find the right person to talk to at Shropshire Council and so far failed. A survey of the village hall will be carried out before the 15<sup>th</sup>. I am going to suggest a letter is written to the chief executive enclosing the completed form requesting transfer of responsibility. At least that may get a response.

**15a.** Clerk has been progressing the loan application since the last meeting. Chair has the form to sign for the permission to borrow money. Clerk has some information to send to SALIX to confirm the loan application. The loan can then be applied for. This will be for 100% of the money for the lights not yet converted. The process has been slow because of Covid-19 disturbing peoples working activities. Plus of other peoples holidays.

## 17. Clerk's activities since last meeting:

- 1. Clerk contacted SGCT regarding a dog bin on Spout Lane. They are investigating. Clerk has informed resident who queried this.
- 2. Reported faulty bus stop at the top of Floyer Lane reported and repair agreed.
- 3. Reported the overgrown trees at the bottom of Benthall Bank.
- 4. Damaged path on Bridge road towards where it becomes Telford. Keir have been invited to a meeting to scope the works. How the repair funded will be determined after.
- 5. Drains on Bridge Road. The cleaner visited in May some drains could not be accessed because of parked vehicles. A return visit will be booked to try again.
- 6. Confirm a letter has been sent to the hedge owner on Bridge Road from Shropshire Council. The car parked is a police matter clerk suggested to the original complainer they report the obstruction to the police.
