### **MINUTES OF BARROW PARISH COUNCIL'S PLANNING MEETING HELD ON TUESDAY 20<sup>TH</sup> AUGUST 2019 AT 6PM AT WILLEY VILLAGE HALL.**

**1. PUBLIC PARTICIPATION:**

**5. PLANNING APPLICATIONS:**

**A. NEW APPLICATIONS TO BE CONSIDERED:**

- 19/03371/FUL Erection of a two-storey detached building to provide a garage and holiday let unit, erection of a single storey oak framed garden room extension to the dwelling following removal of an existing porch/conservatory. Woodside Spout Lane Benthall. It was RESOLVED to make the following comments:

“ Barrow Parish Council has no objection to the garden room. However if the garage and holiday let is allowed Barrow Parish Council asks that a condition is added restricting use to holiday let and not a permanent dwelling.”

**6. FLOYER LANE ALLOTMENTS**

**A. Tenants.** All the plots have been let.

**C. Fencing between Floyer Hall and Allotment Site.** Consider offer of funding to fence Plot E with post and rail fence. It was RESOLVED to defer the fencing between Floyer Hall and the allotment site until the land transfer has taken place and the line of the fencing is confirmed in writing. It was RESOLVED not to fence Plot E. The plot to be treated the same as all other plots.

**D. Trees.** The tree on plot H is slowly being removed. Councillor Churchill has an arrangement with the tenant of the plot to remove the remaining trunk. He was advised to ensure all due care and attention is taken. Clerk reported she now has a contact to obtain a price for a tree survey

**E. Rubbish.** The contractor maintaining the common areas has agreed to remove the rubbish.
